



## Privacy Policy

**Effective Date: June 1, 2025**

Forth respects your privacy. This Privacy Policy explains how we collect, use, and protect your personal information when you visit our website or interact with us.

### Information We Collect

You can browse our website without telling us who you are or revealing any personal information. We only collect personal information when you choose to provide it, such as when you:

- Make a donation
- Sign up for our newsletter
- Participate in a survey or event
- Contact us directly

We may collect your name, email address, mailing address, and payment details (processed securely through third-party providers such as QGive or PayPal).

We also collect limited technical information automatically, such as your IP address, browser type, and pages visited, using cookies and analytics tools to improve our website and understand user preferences.

### Use of Personal Information

We use the information you provide to:

- Process and acknowledge donations
- Send thank-you notes, tax receipts, and member benefits
- Communicate updates, news, and fundraising opportunities
- Improve our programs and website
- Respond to your inquiries

We do **not** sell, rent, or trade your personal information.

### Donor Recognition and List Sharing

Unless you request anonymity, we may publicly acknowledge your donation on our website or in printed materials. You may request anonymity at the time of donation or anytime thereafter.

Occasionally, we may exchange donor names and mailing addresses (not email addresses or financial data) with other nonprofit organizations that share our mission. This helps expand awareness and support for our work. You can **opt out** of this sharing at any time by contacting us at:
